Project sheets shall be two (2) page per project.

### **REPLACE WITH:**

No single project sheet may exceed two (2) pages. No single page shall contain more than two (2) projects.

B. Note the following revisions, deletions and replacements to Sub-Section 04, Criteria No. 2:

Project sheets shall be no more than two (2) projects per page.

### **REPLACE WITH:**

No single project sheet may exceed two (2) pages. No single page shall contain more than two (2) projects.

### **REVISE PARAGRAPH F:**

In addition to the relevant experience required above, full resumes for each of the Key Personnel shall be included as an appendix. Resumes shall not count towards the overall page limit. Resumes must include education, experience, certifications, background, accomplishments, *copies of professional licenses/registrations* and other pertinent information.

3. Except as specifically amended herein, all other terms and conditions of this solicitation remain unchanged and in full force and effect.
